The bids without bid security shall not be entertained. Bids in sealed envelope, prepared in accordance with the instructions in the bidding documents, must reach at the office of Assistant Registrar, Wafaqi Mohtasib Secretariat, RO, Gujranwala on/or before **30th March, 2021 at 10:30AM**. Late submission of bids will not be accepted.

Bids will be opened in Wafaqi Mohtasib Secretariat, RO, Gujranwala on **30th March, 2021 at 11:00AM** in the presence of the bidders or their authorized representatives, who may choose to be present. Rates must be inclusive of GST and other Taxes/duties (if any) as levied from time to time by the Federal Government.
